

In a letter published in the UK's *Sunday Times* and op-ed articles in Swedish financial daily *Dagens Industri* and leading German daily *Frankfurter Allgemeine Zeitung*, leading business people and entrepreneurs across Northern Europe have joined forces to call for a more competitive and democratically accountable Europe. This is the first cross-border initiative of its kind.
